

## NACD FLORIDA CHAPTER ANNOUNCES NEW BOARD OF DIRECTORS CHAIR

With extensive experience as a corporate board member, Scruggs currently serves on the boards of directors of Truist Financial Corp. (NYSE: TFC), which was formed when BB&T and SunTrust combined to become one of the largest financial services companies in the United States; and GuideWell Mutual Holding Corp., parent company of Florida Blue. At GuideWell, Scruggs serves on the Audit and Finance Committees. At Truist Financial, he is a member of the Compensation and Human Capital Committee, and Risk Committee. Previously, he served as a member of the board of Office Depot Inc. and the Board of Regents of the State University System of Florida. He is also a trustee emeritus of the University of Miami.

As demonstration of his commitment to excellence in corporate governance, Scruggs is an NACD Board Leadership Fellow. He received a Professional Certificate in Cybersecurity Oversight from Carnegie Mellon University.

"The Florida Chapter of NACD has created a vibrant community of Florida-based directors, and I am proud to be a part of the chapter's leadership," said Scruggs. "I look forward to helping the chapter continue its trajectory of success in creating platforms for directors to exchange ideas and learn new skills."

Scruggs' history of service as an official of Florida's state government includes being Florida's secretary of labor and employment security and serving as assistant general counsel to the governor. As an attorney, he advises companies and executives regarding employment law, conducts investigations for companies, and litigates employment and commercial disputes. A civil rights activist from a very early age, Scruggs has broken barriers throughout his life and has quietly used his influence and leadership skills behind the scenes to make

policy changes, provide employment opportunities, and fight for equal justice. Scruggs has degrees from Harvard, Princeton, and Cornell.
