Intellectual Property and Business Litigation

- *Southeastern Conference Association of Seventh–Day Adventist v. Guilgal Congregation, et al.*: Successfully represented client at trial and on appeal to the Fifth District Court of Appeal against multiple defendants for fraud, conspiracy to commit fraud, conversion, and breach of fiduciary duty
